**Exhibitor Space Fees & Costs**

BOOTHS: Space is 10' x 8', and comes complete with 8' table, sign, 2 chairs. Each area comes with skirt, curtain, and side rails for a professional appearance. Each exhibitor booth comes with (3) memberships. Base pricing starts at \$575, with corner costs an additional \$100.

ARTIST ALLEY: Space includes a 6' table, sign, and 2 chairs. Amazing Comic Con cannot not guarantee the amount of area behind each artist alley table. Base pricing for AA Tables are \$200.

Please note: The City of Mesa requires Amazing Comic Conventions to collect sales tax on all booth sales, Artist Alley tables, and vendor space.

**Sales Tax Information**

The State of Arizona and the City of Mesa requires all exhibitors selling merchandise at the Amazing Comic Con to obtain a valid transaction Privilege Tax Licenses. It is the responsibility of the exhibitor to obtain the required documentation. Failure may result in the City of Mesa preventing you from exhibiting at the Mesa Convention Center. Amazing Comic Con cannot be held responsible for the failure of a vendor to complete this process. Amazing Comic Con will not issue any refund or reimbursement based on City of Mesa enforcement. We encourage that all paperwork is filed in a timely manner.

**Refunds**

Refunds will only be issued as follows:

Cancel by October 1, 2011 and receive 100% refund

Cancel by November 1, 2011 and receive 50% refund

After this date, refunds will only be granted if booth space is sold for full price.

Also, you will have the option of transferring payment to a future event organized by Amazing Comic Con.

**Liability Policy**

The Exhibitor is fully responsible for any and all damages to property owned by the City of Mesa and/or the Amazing Arizona Comic Con, its owners and managers that may result from any act of omission of exhibitor. The Exhibitor agrees to defend, compensate, and hold harmless the City of Mesa, the Mesa Convention Center, and Amazing Arizona Comic Con, its owners, JayCompany, managers, officers, directors, employees, staff, and affiliates from any damages, losses, costs, or expenses arising from or out of or by reasons of any accident or injury to employees and exhibitor invitees which arises from or out of the exhibitors' occupancy and use of the exhibitor premises, the venue, or any part thereof. The Exhibitor invitee is anyone who enter the exhibit space of sale or for show purposes within the exhibitor room, Palo Verde Ballroom, and any other designated area in the Mesa Convention Center.

#### Security

Amazing Arizona Comic Con will provide security for event, with third party personal on staff at all times from the end of dealer set-up on Thursday January 5th at 7pm though Sunday evening, January 8. Additionally, the Mesa Police Department on call. Even though there will be security, we highly recommend that any cash or valuable materials to be removed from Main Exhibit Hall at the close of each day. We also recommend that that exhibitors take extra care in placement of cash and merchandise at the convention itself. Exhibitors are responsible for their own property, and under no circumstances will Amazing Arizona Comic Con, JayCompany, or its staff beheld responsible for any loss or damage including but not limited to merchandise, equipment, and/or revenue.
